 - Inventory remains the property of the author until sold.
 - Chapter & Verse Bookstore reserves the right to determine the quantity of books displayed based on available shelf space.
 - Authors are responsible for replenishing inventory as requested.

INVENTORY REPLENISHMENT

When inventory becomes low, Chapter & Verse Bookstore will notify the author.

Authors agree to replenish inventory within **14 days**, whenever reasonably possible.

Failure to replenish inventory may result in temporary removal of the title from active promotion until replacement inventory is received.

SALES PAYMENTS

Sales reports will be prepared and distributed **quarterly**.

Payments for books sold will be distributed **within fifteen (15) days after the close of each calendar quarter** using the author's preferred payment method on file.

Balances below **\$25.00** will automatically roll over to the next quarterly payment until the minimum payment threshold has been reached.
